Extended Care Facility

St. Joseph School Extended Care Program is located at the far north end of the school building across from the K3 classroom. It is equipped with age-appropriate furniture and materials and safe outdoor/indoor play equipment. The Extended Care Program reinforces the school's philosophy of teaching Christian values. The curriculum provides a balance of structured and unstructured activities for the children. Fun learning activities are balanced with free play activities. Older students will be provided with a study area to work on homework.

Extended Care Schedule

Extended Care will be open on **all full days of school** from 3:10-5:30pm for all children in grades K3-8th grade. **There is no afternoon care on half days.**

Health and Safety

At this time, masks are optional at school, and Extended Care will be following the school guidelines for preventing illness in our kids. The students come from multiple different classrooms at school, which increases their exposure to illness, so we will also continue to focus on good hygiene manners such as frequent handwashing.

- We will be outdoors after school every day, weather permitting.
- All students will sanitize or wash their hands each time that they enter or leave the classroom.
- Parents and students, not Extended Care staff, are responsible for ensuring that homework is complete and done correctly.
- Cell phones may not be used in Extended Care and must be turned into the supervisor for that classroom upon arrival each day.
- Toys will be sanitized frequently, and additional cleaning of tables and desks and frequent hand sanitizing will be done in accordance with the St. Joseph School policies and procedures.
- If a child or staff member in the Extended Care program tests positive for Covid-19 then the Extended Care participants will be notified according to current school policy.

Late Pick Up

If you will be later than expected to pick up your child, please call the afternoon Extended Care supervisor Kathi Sinclair at 414-659-2998. If the school closes unexpectedly during the day for any reason, you will need to pick up your child immediately. **If you pick up your child/children later than 6:00pm a late fee of \$5.25 will be charged.**

Registration Fees

An annual registration fee of \$40 is required for the Extended Care program.

Extended Care Fees

K3-8th grade: \$5.25/hour from 3:10pm - 5:30pm. There is a 20% multiple children discount.

Supply Fee

Rather than having students bring in the supplies specified on an Extended Care supply list, **there is a supply fee of \$15 per child.** All students who attend Extended Care are assigned this fee. The fee allows for more flexibility in purchasing the necessary quantities and types of supplies needed for children who attend Extended Care.

Snack Fee

K3-8 Extended Care students will be charged a snack fee of \$1.00/child/day for snack and milk. This fee will be included in your monthly bill. All snacks will be pre-packaged individual serving size snacks. Students may bring their own snacks if preferred.

Payment

Statements will be sent home once a month by the 10th of the month. Checks must be made out to St. Joseph School Extended Care. Payments must be made within ten (10) days of receiving the bill. **A late fee of \$10 will be added to bills that are paid after the due date. If bills are not paid, students will not be allowed to return to Extended Care.**

Disciplinary Policy

The disciplinary policy as described in the St. Joseph School parent handbook will be the basis for the discipline in Extended Care.

Illness

If your child becomes ill during the time he/she is in Extended Care, you will be notified. **You are expected to pick up your child when you receive this notification.**

Medication, Allergies, and Injuries

On occasion, it may be necessary for the Extended Care staff to administer medication to a child. The parent needs to complete a Medication Consent Form that remains on file in Extended Care. It is important to let us know of any allergies your child has. If your child is injured in the course of an Extended Care day, you will be notified.

**No child will be allowed to be unsupervised after school.
They must be enrolled in the Extended Care Program.**
