If you are already enrolled in SMART TUITION- payments will be set up with your new tuition amounts and you will receive an email from SMART with your new payment plan.

If you select option 1 and payment is not made by August 1st, 2019, enrollment in the SMART TUITION payment plan is required.

Registration fees are applied to the Total Tuition Due. 25% of the total tuition is due and non-refundable if the student withdraws on or before September 1st. If a student withdraws after September 1st, the tuition due will be prorated. Registration Fees are not refundable.
